## 2. Hazards Identification

**Emergency overview** CONTENTS UNDER PRESSURE.  
Aerosol. Pressurized container may explode when exposed to heat or flame.

**OSHA regulatory status** Harmful in contact with eyes. Prolonged exposure may cause chronic effects.  
This product is considered hazardous under 29 CFR 1910.1200 (Hazard Communication).

**Potential health effects**  
**Eyes** Contact may irritate or burn eyes. Eye contact may result in corneal injury.  
**Inhalation** Intentional misuse by concentrating and inhaling the product can be harmful or fatal.  
**Ingestion** Exposure by ingestion of an aerosol is unlikely. Ingestion may cause gastrointestinal irritation, nausea, vomiting and diarrhea.

**Target organs** Central nervous system. Respiratory system.

**Chronic effects** Conjunctiva. May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion, and blurred vision) and/or damage.

**Signs and symptoms** Corneal damage. Narcosis. Conjunctivitis.

## 4. First Aid Measures

**First aid procedures**  
**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Get medical attention immediately.  
**Skin contact** Immediately take off all contaminated clothing. Wash off with soap and water. Get medical attention if irritation develops or persists.  
**Inhalation** Call a physician if symptoms develop or persist.  
**Ingestion** Have victim rinse mouth thoroughly with water. Do not induce vomiting without medical advice. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. If ingestion of a large amount does occur, seek medical attention.

**Notes to physician** Symptoms may be delayed.

**General advice** If you feel unwell, seek medical advice (show the label where possible).

## 5. Fire Fighting Measures

**Flammable properties** Containers may explode when heated. Vapor or gas may spread to distant ignition sources and flash back.

## Extinguishing media

**Suitable extinguishing media** Water fog. Foam. Alcohol foam. Dry chemical. Carbon dioxide (CO<sub>2</sub>).

**Unsuitable extinguishing media** Do not use a solid water stream as it may scatter and spread fire.

## Protection of firefighters

**Protective equipment and precautions for firefighters** In the event of fire and/or explosion do not breathe fumes. Wear full protective clothing, including helmet, self-contained positive pressure or pressure demand breathing apparatus, protective clothing and face mask. Containers should be cooled with water to prevent vapor pressure build up. For massive fire, use unmanned hose holders or monitor nozzles; if this is impossible, withdraw from area and let fire burn.

## 6. Accidental Release Measures

**Personal precautions** Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering. Keep unnecessary personnel away.

**Methods for containment** Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable.

**Methods for cleaning up** Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean contaminated surface thoroughly.

## 7. Handling and Storage

**Handling** Pressurized container: Do not pierce or burn, even after use. Do not handle or store near an open flame, heat or other sources of ignition. Do not use if spray button is missing or defective. Use only with adequate ventilation. Avoid contact with eyes. Avoid prolonged exposure.

**Storage** Level 3 Aerosol.

Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Keep away from heat, sparks, and flame. Avoid exposure to long periods of sunlight. Store in cool place. Keep in an area equipped with sprinklers. Keep out of the reach of children. Use care in handling/storage.
