## 2. Hazards Identification

**Emergency overview** CONTENTS UNDER PRESSURE.  
Aerosol. Pressurized container may explode when exposed to heat or flame.

## 4. First Aid Measures

**First aid procedures**

**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Get medical attention immediately.

**Skin contact** Immediately flush skin with plenty of water. Remove and isolate contaminated clothing and shoes. Get medical attention immediately. For minor skin contact, avoid spreading material on unaffected skin. Wash clothing separately before reuse.

**Inhalation** Move to fresh air. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.

## 5. Fire Fighting Measures

<b>Flammable properties</b>	Containers may explode when heated. Vapor or gas may spread to distant ignition sources and flash back.
<b>Extinguishing media</b>	
<b>Suitable extinguishing media</b>	Water fog. Foam. Dry chemical. Carbon dioxide (CO <sub>2</sub> ).
<b>Unsuitable extinguishing media</b>	Do not use a solid water stream as it may scatter and spread fire.
<b>Protection of firefighters</b>	
<b>Specific hazards arising from the chemical</b>	Fire may produce irritating, corrosive and/or toxic gases.

## 6. Accidental Release Measures

<b>Personal precautions</b>	Ensure adequate ventilation. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering. Keep unnecessary personnel away.
<b>Methods for containment</b>	Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable.
<b>Methods for cleaning up</b>	Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean contaminated surface thoroughly.

## 7. Handling and Storage

<b>Handling</b>	Pressurized container: Do not pierce or burn, even after use. Do not handle or store near an open flame, heat or other sources of ignition. Do not use if spray button is missing or defective. Use only with adequate ventilation. Avoid prolonged exposure.
<b>Storage</b>	Level 1 Aerosol.  Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Avoid exposure to long periods of sunlight. Keep in an area equipped with sprinklers. Keep out of the reach of children.
