4. First-aid measures

Inhalation

If inhalation of gas/fume/vapor/dust/mist from the material is excessive (air concentration is greater than the TLV or health effects are noticed), immediately remove the affected person(s) to fresh air. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Call a physician or Poison Control Center immediately. Skin contact

Most important symptoms/effects, acute and delayed

5. Fire-fighting measures

Suitable extinguishing media

Powder. Alcohol resistant foam. Dry chemicals. Carbon dioxide (CO₂).

Specific hazards arising from the chemical

Contents under pressure. Pressurized container may explode when exposed to heat or flame. Fire may produce irritating, corrosive and/or toxic gases.

Special protective equipment and precautions for firefighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Firefighters should wear full protective clothing including self contained breathing apparatus. Structural firefighters protective clothing will only provide limited protection.

Fire-fighting equipment/instructions

In case of fire and/or explosion do not breathe fumes. 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Consider initial downwind evacuation for at least 500 meters (1/3 mile). Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Many gases are heavier than air and will spread along ground and collect in low or confined areas (sewers, basements, tanks). Wear appropriate protective equipment and clothing during clean-up. Avoid inhalation of vapors and spray mists. Avoid breathing gas. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Methods and materials for containment and cleaning up

Keep out of low areas. Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Use water spray to reduce vapors or divert vapor cloud drift. Isolate area until gas has dispersed. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water.
